- **Voor geluid overzicht dag / avond / nacht.**



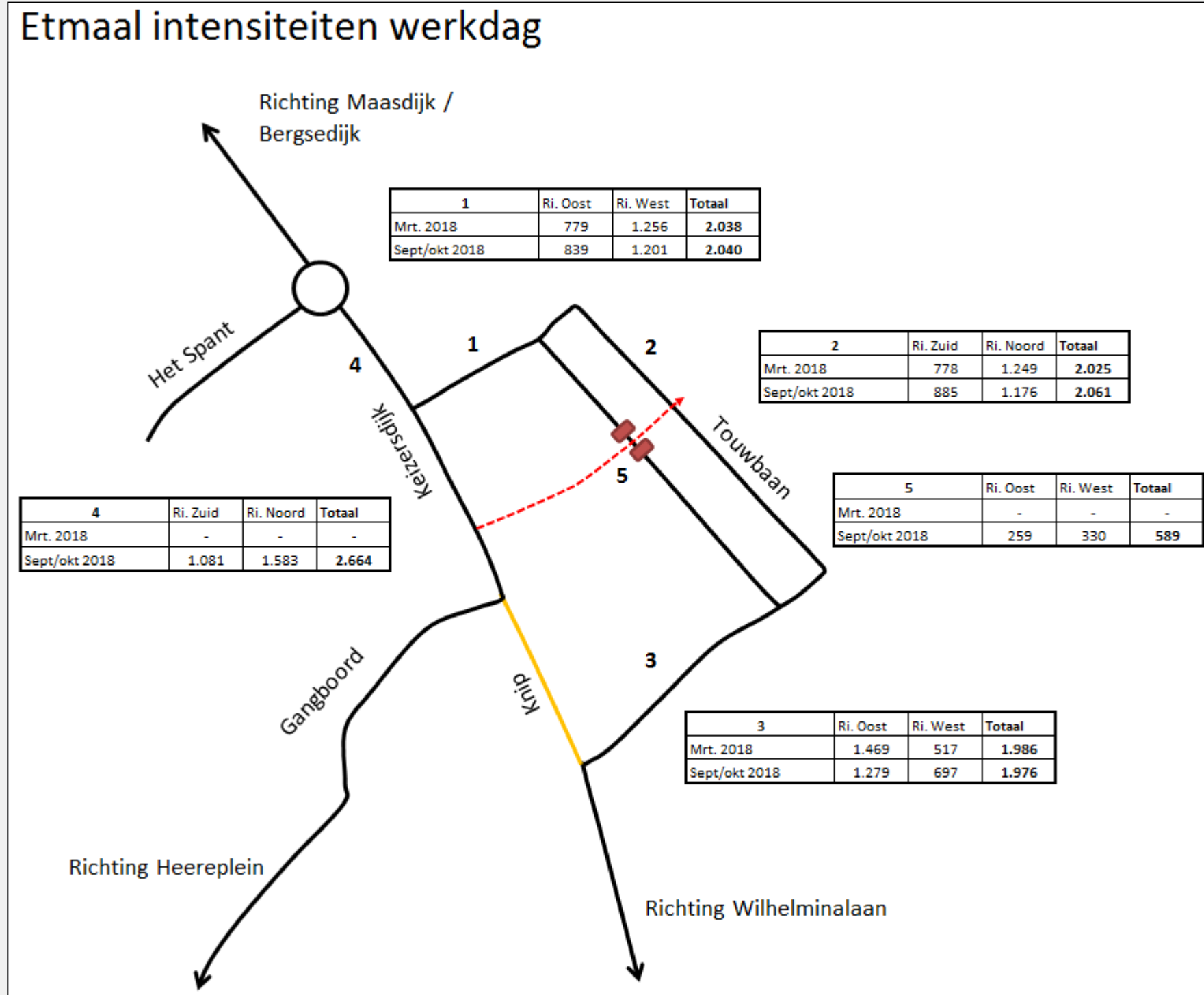

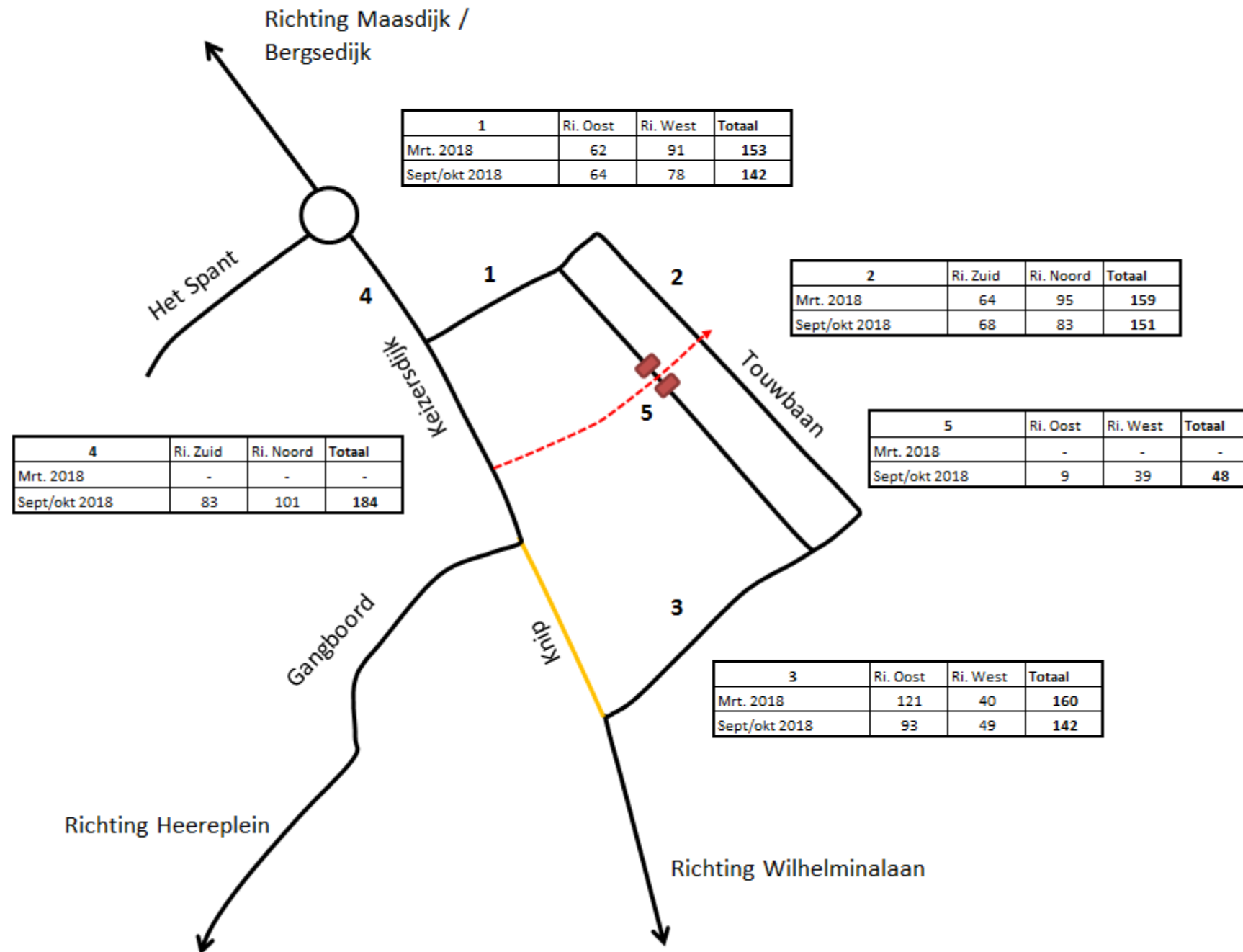

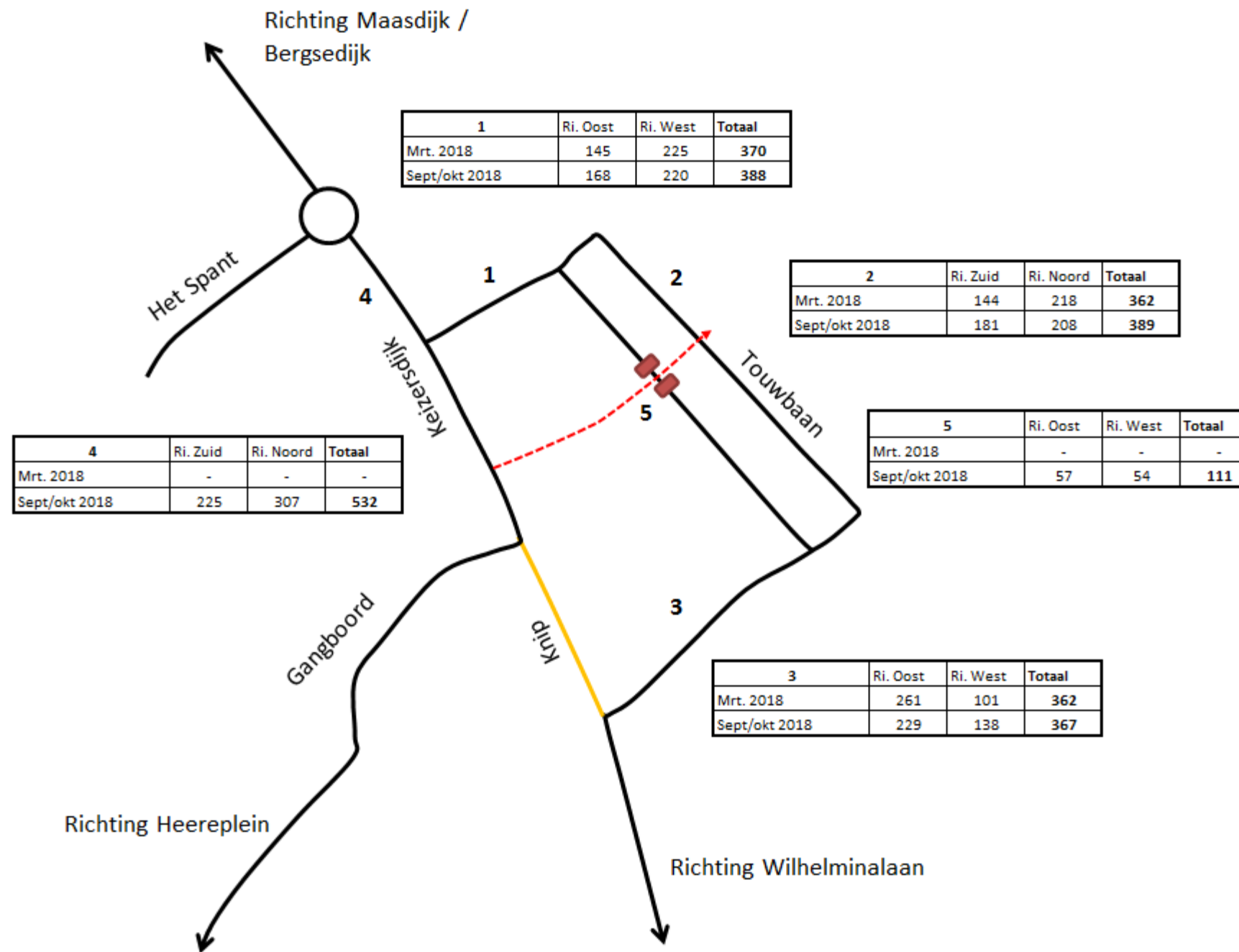

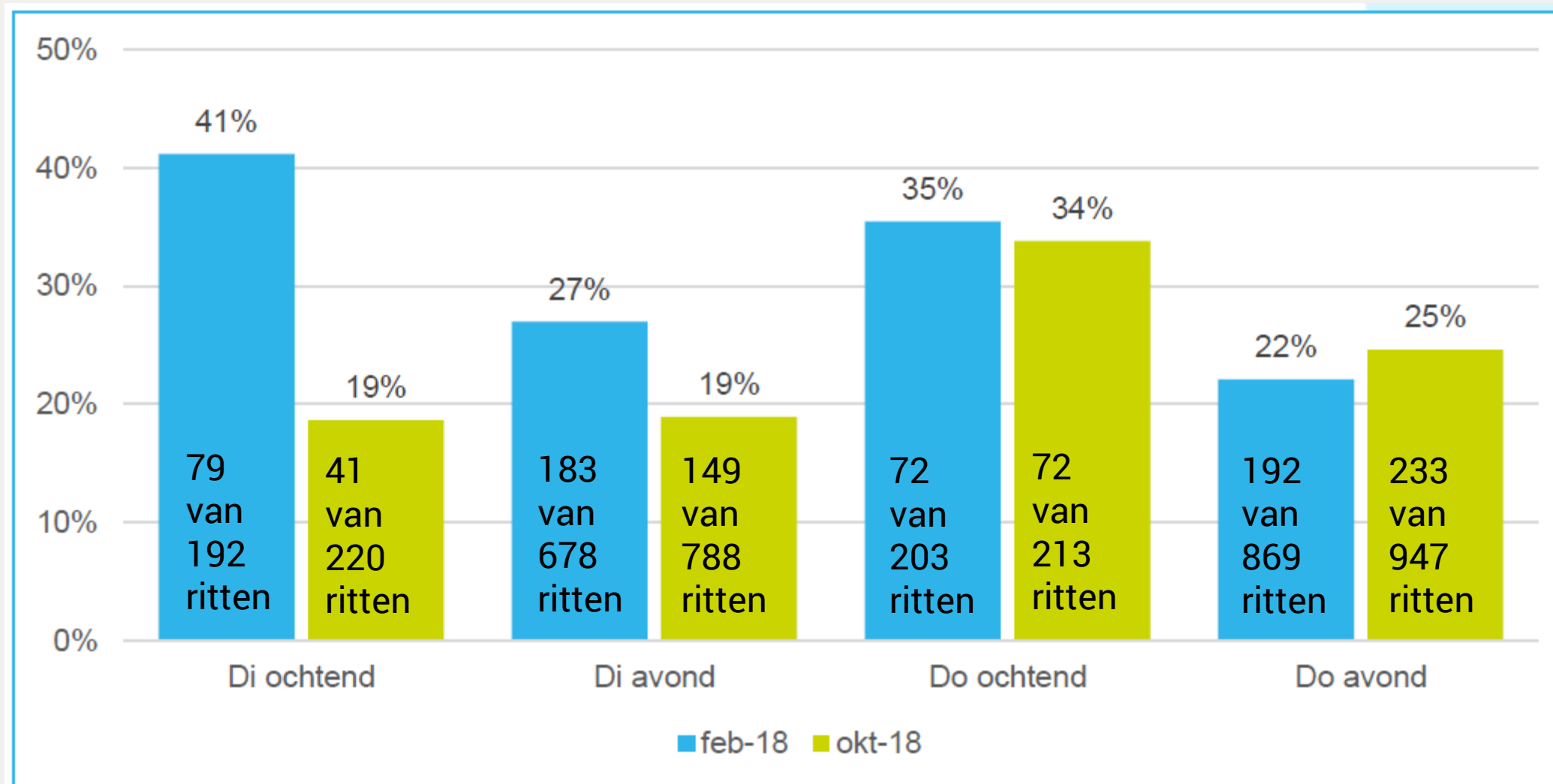
